# PROPOSED AMENDMENT TO THE ASSOCIATION'S ARTICLES OF ASSOCIATION AND PROPOSED RULE CHANGE - 2016/17 RULES

Proposed amendment to the Articles of Association

Given the growth of the Association and that the Board continues to be representative of its broad Membership base, it is proposed that the Association's Articles of Association be amended to permit an increase in the maximum number of Directors. The proposed amendment to Article 8.1 is italicised and set out in Appendix "A" (see attached).

Additionally, recent changes in the regulatory environment in the United Kingdom mean that a representative from the Managers should be appointed to the Board of the Association. Article 8.2 provides that the Managers are not permitted to take up such an appointment and therefore it is proposed that Article 8.2 be deleted, as set out in Appendix "A".

#### Proposed Rule Change

It is also proposed that amendments be made to Rule 10 of the Association's Rules to remove the current restriction on reinsured entries becoming Members of the Association. The proposed amendment allows this in circumstances where the Directors so agree.

The proposed amendment to Rule 10 (2) is italicised and set out in Appendix "B" (see attached).

### **APPENDIX "A"**

# AMENDMENT TO THE ASSOCIATION'S ARTICLES OF ASSOCIATION

# **ARTICLE 8. DIRECTORS' APPOINTMENTS**

- 8.1 The number of directors shall be no less than six and no more than 22 25, unless otherwise determined by ordinary resolution.
- 8.2 No Manager, nor any employee of any Manager, shall be eligible for appointment as, nor shall they be capable or of holding the office of, a Director.

#### **APPENDIX "B"**

#### **RULE AMENDMENT**

## Rule 10: Membership

(2) If the **Association** accepts an application for **Entry** of a **Ship** from an insurer, any **Ship** in respect of which the application is made shall be entered by way of reinsurance and shall for the purposes of these **Rules** be an **Entered Ship** and the **Owner** of that **Entered Ship** and the insurer reinsured may each, in the discretion of the **Directors**, be accepted as a **Member** on such terms as may be agreed by the **Directors**. If the insurer concerned does shall not become a **Member**, but he shall in all other respects have the same rights and be under the same obligations for the purposes of these **Rules** unless otherwise agreed by the **Association**. His contract with the **Association** shall for all purposes take effect as though he were the **Member** in respect of any such **Entered Ship** and in such capacity had entered any such **Ship** in the **Association**.
