RULE AMENDMENT

Rule 17(3): Termination of Cover

The proper draft amendments to the Rule are as follows:

"Notwithstanding anything in the Rules to the contrary, the Association may, where an Entered Ship is being or may be employed by the Association determines that an Entered Ship is being employed by a Member in a carriage, trade or voyage which may in anyway whatsoever expose the Association to the risk of being or becoming subject to any sanction, prohibition, restriction or adverse action in any form whatsoever by any state, competent authority or government, suspend the cover of the Member until further notice pending investigation by the Association or, at any time the Association determines it is exposed to such risk, terminate the cover of the Member with immediate effect by written notice. by written notice terminate the cover of the Member with immediate effect."

PROPOSED RULE CHANGES - 2020/21 RULES

Given the ever changing nature of international sanctions regimes it is proposed that an amendment be made to Rule 17 (3) Termination of Cover to permit the Association to undertake reasonable investigations as to its risk of exposure to secondary sanctions in addition to permitting a decision to be taken as to termination of an entry.

The proposed Rule change is to be considered at an Extraordinary General Meeting to be held on 23rd January, 2020. If approved the revised Rule will take effect from 20th February, 2020.
