## Appendix A

## Article 1.1

Primary Insurance means insurance or reinsurance afforded by The UK Defence Club or The UK Defence Club Europe.

The UK Defence Club Europe means The United Kingdom Freight Demurrage and Defence Insurance (Europe) Ltd, a company incorporated in Cyprus with registration number HE399596.

### Article 3.1

Any person for whom The UK Defence Club or The UK Defence Club Europe has or will have afforded Primary Insurance shall become a Member in accordance with these Articles and be bound by these Articles if and with effect from the date respectively on which such Primary Insurance afforded by The UK Defence Club or The UK Defence Club Europe to such Member shall be reinsured by The UK Defence Club with the company.

### Article 57

In the event of the winding up of the Company, after its debts and liabilities have been satisfied and all costs, charges and expenses of winding up have been satisfied, the remaining assets of the Company ("the Remaining Assets") shall be distributed in cash or in specie in such and equitable manner amongst the Members and in the same proportion as the Members (in their capacity as members of The UK Defence Club) contributed to The UK Defence Club and The UK Defence Club Europe during the period of six years immediately preceding the commencement of the winding-up, and the certificate of the liquidator as to the amounts of the contributions so paid shall be conclusive.

## Appendix B

## 2. Interpretation

### 2.1

"Primary Insurance" means insurance or reinsurance afforded by UK or UKE.

"UKE" means The United Kingdom Freight Demurrage and Defence Insurance (Europe) Ltd, a company incorporated in Cyprus with registration number HE399596.

## 3. Membership

### 3.1

Any person to whom UK or UKE shall afford or shall have afforded Primary Insurance shall become a Member if and with effect from the time and the date on which such Primary Insurance afforded to such Member shall be reinsured by UK with the Association and any such Member shall be liable for Special Calls in accordance with Rule 4.
